



## Special Considerations for Your Attention

### Passport Instructions

1. Your passport must be valid at least through May 13, 2022.
2. Your passport must be signed and have at least two blank pages (without entry visas, stamps, etc.).
3. If applying for, or renewing your passport, please indicate as such in the space provided on your registration form.
4. Send a color copy of the inside identification pages of your valid passport to the Israel Advantage Tours office as soon as you receive your new passport. Email is acceptable.
5. Ensure that the name you enter on your Participant Tour Registration Form matches your name EXACTLY as it appears on your passport.
6. Discrepancies in information of your name, birthdate, country of residence, and passport number, or failure to update Israel Advantage Tours, Inc., in a timely manner regarding the spelling of your name or name changes on your passport, may result in penalties from the airline, penalties you will incur. These penalties can be costly.

**Please ensure that the name as you have it spelled on all of your registration forms corresponds EXACTLY with the spelling of your name in your passport.**

### Please note

1. The Suggested Sites Itinerary in your Tour Brochure made part of the Passenger Agreement Package is subject to changes in sequence of days, weather and time permitting, local conditions, and preferences of the tour leader. Hotels may be substituted with hotels of similar and comparable standards.
2. Airline luggage fees may apply. These fees vary by airline and are at the airline's discretion on each segment of the flight itinerary. Additionally, you may incur optional fees (food, excess baggage, overweight baggage, items of personal nature, etc.) as well. Information will be available at the Pre-Departure Orientation closer to the date of departure.
3. Your Fit to Travel Statement: Passengers registering for the tour accept the responsibility for being in good health and able to walk and travel on the tour. Because many of the sites are not accessible to individuals with physical challenges, those needing oxygen, wheelchairs, or other ambulatory assistance will find the tour extremely limited to their experiences.
4. Participation on this tour is based on a first-come-first-served basis.
5. Participation is not limited and per person cost is based on a minimum of 50 passengers
6. It is customary to acknowledge your tour guide and bus driver with a love offering at the conclusion of the tour. The love offering is at your discretion and is not included in the cost of the tour.
7. For your record-keeping, please make copies of your completed, signed, and dated Participant Tour Registration Form and Travel Terms and Conditions. Each passenger must complete, sign, and date their own registration forms.

When you receive your tour invoice....

It is your responsibility to make sure that all information on your tour invoice is correct. The name on your tour member invoice is the name you provided on your Participant Tour Registration Form. The name you provided and the name as it appears on your passport must match **exactly**. The name you provide will be the name under which airline tickets will be secured for you.

The Transportation Security Administration has mandated that passengers must travel under their name as it appears on their passport in order to board an airplane for international travel. Therefore, the passenger's name must appear on their airline tickets **exactly** as the passenger's name appears on their passport. The passenger's name cannot be misspelled. Your first, middle, if any, and last names must appear on your airline ticket **exactly** as your name appears on your passport.

It is imperative that you review your name as it appears on your tour member invoice and ensure that your name matches your name **exactly** as it appears on your passport. If the name on your tour member invoice does not match your name as it appears on your passport, please advise our office immediately.
